Production Services

<p>HALF HOUR SHOW - \$125 per half-hour x 8 Shows for \$1000 Work started after payment received, need 14 days in advanced prior to airing.</p>
<p>Show Host Start-up Kit: \$225</p> <ul style="list-style-type: none"> • Show Marketing Kit (Multi-use Banner and Album Cover template) • Intro/Outro with Music • Placement on Website and Liner for station imaging/promotion • Show Host can add up to 2 personal business for promo liners for only \$50 each
<p><i>~ Show Hosts MUST be a licensed nurse with an active license and in good standing with no derogatory issues on license or criminal background. Show hosts will be released immediately upon discovery. Special consultants such as financial experts, etc. are allowed to guest host. ~</i></p>

Contract Terms

The Show

- The Nurses Station, LLC will produce and air shows in one half hour or one hour increments on behalf of the host for the period specified above and will be rebroadcast at approximately twelve hours after original broadcast.
- Host retains rights to use their show recordings as desired including making multiple copies for sales or giveaway, other broadcasts, marketing, and promotional tools without additional fees to The Nurses Station, LLC.
- The Nurses Station, LLC retains the right to broadcast shows produced under this agreement on our network free of any royalty fees to the host. Any show used on the Nurses Station from outside source also can be replayed and used on podcast free of any royalty fees to the host.
- Host controls all weekly topics/content and guests on show, provided they conform within the Mission Statement of The Nurses Station, LLC and are credible.



- Host will make reasonable efforts to promote host's own show in host newsletter and/or website. Host have available the 64k MP3 download of each show at no charge, or a high quality CD copy for an additional fee of \$20.00 per show to include shipping and handling within the United States.
- Host is responsible to plan show, schedule guests, and provide show description outlines.

Host services provided by The Nurses Station, LLC

- In-house Producer assigned to your show.
- Host Bio Page with link to archives and to Host's own website.
- All shows archived indefinitely for download and 60 days for on demand streaming for all current hosts.
- Connections to 1000's of other medical professionals in our communities through our vast data base of contacts.

Sponsorships

- Host may secure sponsors for show and retain 50% of funds.
- The Nurses Station reserves two (2) minutes per half-hour for cross promotion of shows and network ID's.
- Hosts are asked to limit to 4 sponsors prerecorded ad time for products, services or sponsorship or one main sponsor.
- Host will record all announcements and sponsorships in their own voices.
- Hosts are responsible for all costs associated with the above prerecorded announcements. The Nurses Station, LLC is available for assistance at an additional fee.

Music

- Due to music industry requirements, The Nurses Station, LLC must remove any copyrighted music from the archives, recordings, shows, etc.

Non-cancelable

- Contract and Contract Fees are non-cancelable and all fees related to program are non-refundable.

General

- The Nurses Station, LLC will undertake all reasonable efforts to provide technical assistance under this Agreement and to rectify or provide solutions to problems, if any, that Host may experience with a show. The Nurses Station, LLC is not liable for incidental, special or consequential damages for any reason (including loss of profits, loss or interruption of business, loss of data or other business or property damage), even if The Nurses Station, LLC has been advised of the possibility of such a claim by the Host. The Nurses Station, LLC's liability shall not exceed the fees that Host has paid under this agreement during the period in question. Host agrees that the pricing for these services would be substantially higher but for these limitations.
- This Agreement shall be construed, governed, interpreted and applied in accordance with the laws of the State of Texas, without giving effect to conflict of law provisions. This



Agreement embodies the entire understanding between the parties relating to the subject matter hereof and supersedes all prior understandings and agreements, whether written or oral.

- This Agreement may not be varied except by a written document signed by duly authorized representatives of both parties.
- If the quality of the recorded show, sound or content does not meet the needs of the Nurses Station mission and Executive Producers approval, the show can be rejected and no refund on the production will be granted.

NON-COMPETE

Upon termination of this agreement between the Host and The Nurses Station for any reason, the Freelancer must wait no less than 365 calendar days before Host can engage/create an internet-based or broadcast based show with the same name and/or content matter.
